



## TERMS AND CONDITIONS FOR REPRODUCTION OF IMAGES

Reproductions in an electronic or multimedia product are subject to additional terms and conditions.

1. Permission is granted only for one usage in one publication, one edition, and in one language. Additional language editions and subsequent revised new editions will be considered upon application. Photographic material may not be reused without the written permission of The Arkell Museum at Canajoharie.
2. Reproduction from printed or other non-photographic material or from photographic material not supplied by The Arkell Museum at Canajoharie is prohibited.
3. Fees for photography and reproduction must be prepaid.
4. The complete credit line must appear with the reproduction. The credit line, placed near the image, must include the wording: "Courtesy of The Arkell Museum at Canajoharie" and the artist's name, title of work, date, and medium. In case of film or video, visual credits must appear at the beginning or at the end of the production.
5. The image(s) may not be cropped, bled, or overprinted and nothing may be superimposed on the reproduction(s). A specific detail must be approved in advance by The Arkell Museum at Canajoharie, and the word "detail" must appear in the caption. The entire image with complete documentation must appear elsewhere in the publication.
6. Materials should be destroyed or returned to the museum upon completion of the project.
7. Applicant will be charged \$300.00 for the replacement of a lost or damaged transparency.
- 8. A color proof is required prior to publication for approval and will be sent to The Arkell Museum at Canajoharie, Attn: Rights & Reproductions.**
9. In consideration for this permission, two copies of the publication will be sent to The Arkell Museum at Canajoharie, Attn: Research Curator.
10. Failure to adhere to the terms and conditions listed will result in penalty fees of up to 100% of original fees.

**Please note that fees charged do not include any copyright fees due to the artist or the artist's estate. It is the responsibility of the applicant to clear copyright.**

## **ADDITIONAL TERMS & CONDITIONS FOR REPRODUCTIONS IN MULTIMEDIA PRODUCTS**

1. The client is responsible for preventing third-party access to the images in the product. The Arkell Museum at Canajoharie requires that the images not be reemployed, redistributed, or accessible as individual or identifiable files. Specifically, the client must take measures to assure the images will not be extracted or otherwise duplicated in the normal course of using the product except to print pages for personal use.
2. The client must assure that the product includes a clear notice of copyright warning on the packaging and as a screen display included in the product. The warning notice must acknowledge the copyright of the Arkell Museum at Canajoharie and state in all relevant languages that the contents are protected by copyright law.
3. Upon completion, all digital copies of the image must be destroyed. No further copies of the image may be made except those made from a master as a part of the production run to be distributed and sold in any additional production run.
